



## **Information on the processing of personal data for: IS epidemiological tracing (COVID-19)**

**Information on the processing of personal data of data subjects pursuant to Sections § 19 and § 20 of Act No. 18/2018 Coll. on the Protection of Personal Data and on Amendments and Additions to Certain Acts (hereinafter referred to as "the Act") and Articles 13 and 14 of Regulation 2016/679 of the European Parliament and of the Council (EU) on the protection of individuals with regard to the processing of personal data and on the free movement of such data (hereinafter referred to as "the Regulation")**

The purpose of this information is to provide you with information about what personal data we process, how we handle it, for what purposes we use it, to whom we may disclose it, where you can obtain information about your personal data and exercise your rights in relation to the processing of your personal data.

### **1. Purpose of processing of personal data and legal basis for processing**

The purpose of the processing of personal data is: to ensure epidemiological tracing and protection against the spread of the COVID-19 pandemic, to support those infected with COVID-19 for the recall of personally contacted persons during the incubation period until confirmation of the infection.

Personal data are processed on the basis of: the consent of the data subject Article 6, Section 1, Letter (a) of the Regulation, the fulfilment of the legal obligation of the operator Article 6, Section 1, Letter (c) of the Regulation, Act No. 355/2007 Coll. on the Protection, Promotion and Development of Public Health and on Amendments and Additions to Certain Acts, as amended, and DECREE No. 208 of the Office of Public Health of the Slovak Republic ordering measures in case of a threat to public health on restrictions of mass events published in the Government Gazette of the Slovak Republic on 14 May 2021, § 2 General measures for the holding of mass events.

#### **Legitimate interests of the operator or of a third party**

The processing of personal data for the purpose of the legitimate interests of the operator or a third party is not carried out.

### **2. Identification of the personal data of the data subjects processed**

The data subjects about whom personal data are processed are: the person infected with COVID-19 and persons who have come into contact with these persons. Personal data processed in accordance with DECREE No. 208 of the Office of Public Health of the Slovak Republic, which prescribes measures at risk to public health to limit mass events published in the Government Gazette of the Slovak Republic on 14 May 2021, § 6 Measures for the performance of mass events of a cultural nature.

Scope of personal data processed: name, surname, town, telephone number or e-mail.

### **3. Identification of beneficiaries, categories of beneficiaries**

The operator may disclose personal data to authorised entities such as institutions and organisations whose processing is permitted by specific legislation or to contractors (in particular processors) who have contractually undertaken to take appropriate safeguards for the protection of the personal data processed, as follows:

With the consent of the data subject or on his/her instructions, personal data may be disclosed to other recipients.

#### **4. Transfer of personal data to a third country/international organisation**

Transfers to third countries or international organisations are not carried out.

#### **5. Identification of the source from which the personal data were obtained**

Personal data collected from a visitor to a Public Aviation Event when purchasing a ticket online, or purchasing a ticket at the venue, or registering a VIP visitor to an invitation delivered to them.

#### **6. Retention period of personal data**

The operator shall process personal data for the period necessary to fulfil the purpose, but for a maximum of 14 days. After the expiry of this period, the personal data collected will be destroyed.

#### **7. Profiling**

The operator does not process personal data by profiling or in a similar way based on automated individual decision-making.

#### **8. Rights of the data subject**

The data subject has the right to request from the operator access to the personal data processed about him or her, the right to rectification of personal data, the right to erasure or restriction of the processing of personal data, the right to object to the processing of personal data, the right to the ineffectiveness of automated individual decision-making, including profiling, the right to the portability of personal data, as well as the right to submit a petition to the supervisory authority. Where the operator processes personal data on the basis of the data subject's consent, the data subject shall have the right to withdraw his or her consent to the processing of personal data at any time. The withdrawal of consent shall not affect the lawfulness of the processing of personal data based on consent prior to its withdrawal.

#### **9. Obligation to provide personal data**

The data subject provides his/her personal data voluntarily, on the basis of consent (the provision is not a legal/contractual requirement), in case of non-provision, the operator will not provide the data subject with the service. Personal data may also be provided on the basis of a legal requirement, in which case the data subject is under an obligation to provide personal data, failure to do so may result in a breach of the law.
